**STCW 95 - INTRODUCTION AND IMPLEMENTATION SEMINAR  
AND WORKSHOP  
MALTA 14 - 15 SEPTEMBER 1998**

The Merchant Shipping Directorate in collaboration with Germanischer Lloyd are organising a seminar and Workshop on *STCW 95 - Introduction and Implementation*.

This activity is being held at the Holiday Inn Crowne Plaza on Monday 14 and Tuesday 15 September, 1998. Both the Seminar and Workshop will be conducted in the English language and will be led by Mr. Rolf Schulte of Germanischer Lloyd.

The STCW implementation Seminar will introduce the 1978 International Convention on Standards of Training, Certification and Watchkeeping for Seafarers focusing in particular on the very important 1995 amendments (STCW 95). Particular attention will be given to the implications for shipping companies and the implementation of possible preventive measures. The seminar is intended to provide comprehensive information on owner/operator related matters and will also address the procedures introduced by the Malta flag Administration to comply with the Convention.

The Workshop aims to provide detailed implementation examples and case studies to enable participants ensure compliance with STCW 95.

Participation at both Seminar and Workshop will be beneficial, inter alia, for shipowners and operators as well as personnel of the technical, human resource, quality assurance and training departments.
